Waterfront Overlay Ordinance Threatened! Council Members Spelman and Riley Break Campaign Promises to Honor the Waterfront Overlay Ordinance *by Lorraine Atherton, ZNA co-president*

IT SEEMS LIKE just a few weeks ago that the City Council reinstated the Waterfront Overlay Ordinance that Austinites have worked so hard to preserve for decades, but a majority of the council members have already voted to approve a South Austin project that violates the development limits of the overlay. For the members of Save Town Lake, the Austin Neighborhoods Council, and others who care deeply about the beauty of Austin's lakefront, the biggest shock was the vote of our two new council members, Chris Riley and Bill Spelman, who had pledged unequivocally in their election campaigns to support and protect the Waterfront Overlay.

Adherence to the ordinance has been crucial to ZNA's ability to work with developers along Restaurant Row to achieve superior projects with real community benefits, without destroying the vistas and green space that we all value on Lady Bird Lake. That's why ZNA must ask you, once again, to write to the City Council and urge them to honor the overlay and demand more from this project when it comes *(Continued on page 7)*

◆ Texas Votes November 3 ◆

TEXANS WILL VOTE on 11 constitutional amendments in the upcoming general election on Tuesday, Nov. 3, 2009. Early voting begins Monday, Oct. 19, and ends Friday, Oct. 30. On Election Day,

- ✓ Precinct **332** votes at Zilker Elementary School, on Bluebonnet at Hether.
- ✓ Precinct **462** votes at the MHMR office at 1700 South Lamar, Suite 101, off Collier.
- ✓ Precinct **342** votes at Barton Hills Elementary School, at 2108 Barton Hills Drive.

The League of Women Voters and the Public Affairs Forum of the First Unitarian Universalist Church of Austin are hosting a forum on the amendments, with Senator Kirk Watson as the featured speaker, on Oct. 18 at 11:30 AM at the church (4700 Grover). The League's voter guide to the election is available at www.lwvtexas.org.

Propositions 2, 3, 5, and 11 address some property appraisal and tax issues that have been hot topics in Austin. Although the Travis Central Appraisal District has *(Continued on page 11)*

TreeWheelin' Bicycle Tour Celebrates Zilker Oaks

IN 1976, more than 200 of Austin's oldest, largest, and most notable trees were inducted into the City of Austin Bicentennial Tree Registry and featured in a car tour of Austin trees. Now, thirty years later, the TreeWheelin' Bicycle Tour aims to honor these trees—they are our oldest citizens and most efficient city workers—and to recognize the valuable role of the urban forest in providing clean air and water, absorbing storm runoff, saving millions of dollars annually in energy costs, and beautifying our city.

On October 24, from 9 AM to noon, fifty trees across the city will be included on pedal, bus, and walking tours, with volunteers stationed at each stop to provide information about the trees, maps, and refreshments.

In the Zilker neighborhood, you will be able

to visit with Gardner Sumner about the magnificent live oaks at 1001, 1004, and 1206 Garner. The tour also includes live oaks at 903 Jessie and Matt's El Rancho, a cottonwood near Lou Neff Point, and cypress trees on Lady Bird Lake at Barton Creek and in Zilker Park.

Guided bike rides will start at Pease Park, and cyclists can choose from advanced, intermediate, and beginner routes. The event will end with a celebration of TreeFolks' twentieth birthday. Register online at www.treefolks.org or in person on October 17 (10-noon) at Bicycle Sport Shop on South Lamar.

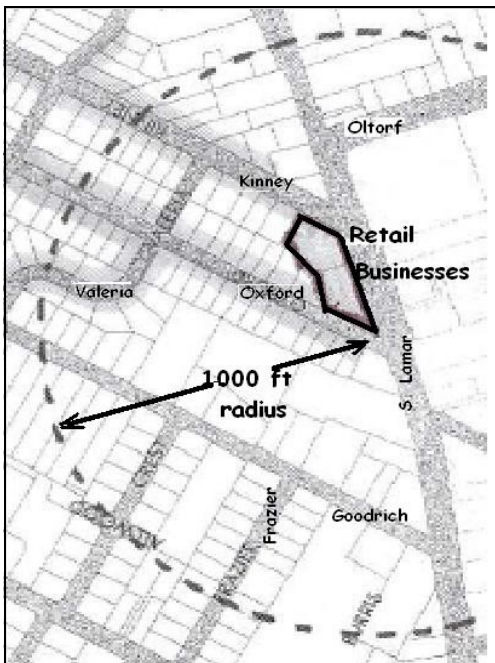

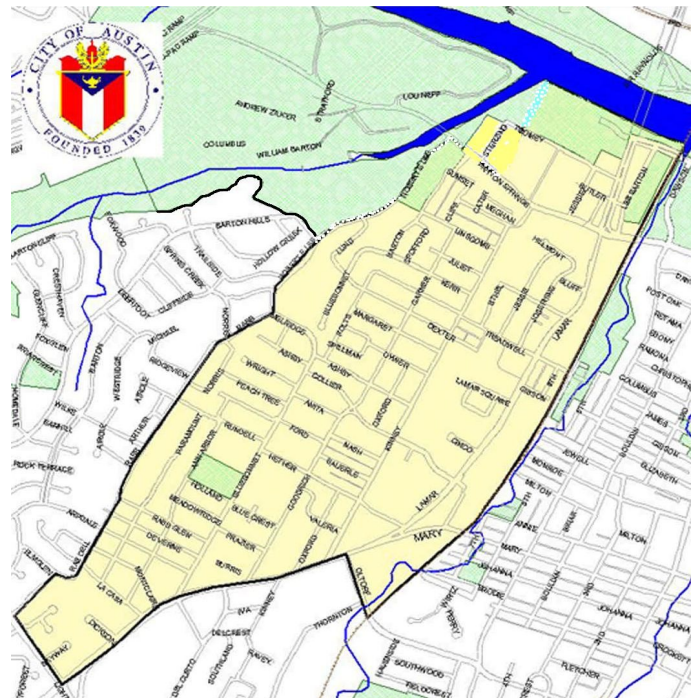

(Continued from page 1) before them on October 22 for second reading. Here's some background from Jeff Jack, a former president of ZNA and a founder of Save Town Lake.

The Grayco PUD and a Dangerous Precedent on the South Shore of Lady Bird Lake

The Waterfront Overlay (WO) Ordinance was crafted to ensure that Austin maintains the scenic vistas and spaciousness of the Colorado River Corridor, now known as Lady Bird Lake. It defined what was reasonable development around our lakefront by setting limits on such things as the height of buildings, impervious cover, and set backs from the lake and the adjacent parkland. During the recent City Council election campaigns, candidates Bill Spelman and Chris Riley both said, in written responses to the Austin Neighborhoods Council and Better Austin Today PAC questionnaires, that they would not vote for projects that violated the WO. Now that they have been elected, however, they both voted to support a developer's request for additional height above the limits set in the WO.

That project, known as the South Shore Planned Unit Development (PUD), by Houston developer Grayco, currently has MF-3 zoning that would allow 40 feet of height. The WO for that area would allow them to go to 60 feet, an increase of entitlements of 50%, if they provide significant community benefits. But Grayco is asking to go to 90 feet, an increase of 30 feet or a 50% increase over the 60 feet that the WO would allow. While the developer has proposed many community benefits that may justify going from 40 feet to 60 feet, it in no way should be used to support violating the WO limit of 60 feet. Not only will this then allow for buildings on the edge of our town lake parkland to tower over the existing tree line, forever hemming in this urban oasis with tall buildings, but it will also set a precedent for all future development along our shoreline. If the City Council gives final approval for the South Shore PUD, then every developer will be encouraged to file for PUD zoning and will in effect render the Waterfront Overlay ordinance irrelevant. Unless the project is made to conform to the WO, then every piece of land in the Waterfront Overlay around Lady Bird Lake will be open to the highest bidder. If violating height limits is approved now, we can expect that other safeguards of the WO, (Continued on page 10)

(Continued from page 7) such as impervious cover limits and setbacks, will be next on the chopping block.

Mayor Lee Leffingwell and Council Member Laura Morrison have voted against the South Shore PUD on first reading. We thank them for their vote to protect Lady Bird Lake. Now the project is going for a final vote on October 22, and if Council Members Spelman and Riley are convinced to honor their campaign promise not to vote for any project that violates the WO, then this project will not pass as currently proposed. The developer can develop a reasonable project at 60 feet, making a good return on their investment, that warrants the

community benefits being proposed. But we do not have to give up our lake front just for added private gain.

If you want to preserve the scenic vistas and feeling of open space around Lady Bird Lake, If you want to make sure that now and in the future projects conform to the Waterfront Overlay and do not use the PUD zoning to circumvent the community's desire to protect our lakefront, then please contact Council members Spelman and Riley before Oct. 22 and ask them to change their vote and honor their campaign promise to respect the WO and protect Lady Bird Lake.

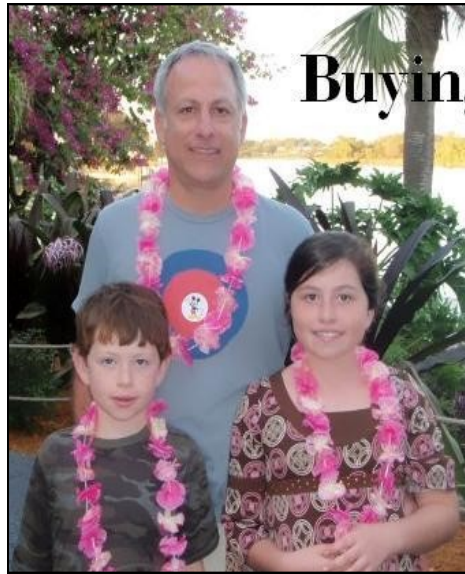

(Continued from page 1) received a huge number of protests and the fairness of residential and commercial appraisals has been questioned this summer, there has been little discussion of these propositions.

Proposition 2 concerns taxation of a homestead "solely on the basis of the property's value as a residence." Prop. 3 would set "uniform standards and procedures" for property tax appraisals. Prop. 5 would allow the consolidation of boards to hear appeals of property appraisals. Prop. 11 prohibits the use of eminent domain "for certain economic development or enhancement of tax revenue purposes." Another proposition that may be of special interest in Austin is Prop. 4, to transfer the higher education fund to a "national research university fund," which would not be available to the University of Texas at Austin or Texas A&M.
