

## Connecting with New Places to Walk and Bike

Sidewalk and bicycle improvements on South Lamar and within Zilker are not waiting for the corridor plan (see page 3). Sidewalk projects completed in the last few months include the 1500

block of Treadwell (right), Treadwell at Lamar Union (center right), the Hanover apartments at 809 S. Lamar (bottom), the sidewalk connecting the Mary Lee Foundation to S. Lamar (left), and, not pictured, the Cielo apartments at Manchaca and repairs



to the sidewalk on Hether. Also, new bike lanes have been striped on the recently repayed blocks of South Lamar south of Barton Skyway.

With the completion of the Treadwell sidewalk and the repairs to the Hether sidewalk, the top priority from ZNA's 1999 wish list is closing the gap in the Melridge sidewalk, between Zilker Skyline and Ashby. There is currently no sidewalk connecting the school and Bluebonnet Market to the sidewalk on Robert E. Lee and Zilker Park.

## Fairy Alley Adds Sparkle to New Treadwell Streetscape

THANKS TO SUVI AIKA and to WaBuCy, the sidewalk on



Treadwell is complete, connecting the Kinney sidewalk to the new Lamar Union streetscape and South Lamar. Suvi got the project started last year, and WaBuCy helped her complete the agreement with the City Neighborhood Partnering Program to fund it. The best part is, Fairy Alley has been rejuvenated as an "art placement." ## South Lamar Corridor Study Open House



## Outdoor Music Venue Update

UNCLE BILLY'S LATE-HOURS permit was approved by the Planning Commission on March 24, including the conditions in the revised sound agreement approved by the ZNA membership at our last general meeting, on March 9. The restaurant's owner, Rick Engel, negotiated similar agreements with the Lost Canyon and Talisman homeowner associations, with restrictions on weekday hours and on the volume of patio speakers.

The restaurant's Outdoor Music Venue (OMV) permit has also been renewed, incorporating the revised sound agreement. Uncle Billy's is at 1530 Barton Springs Road.

The terms for all OMV permits within ZNA boundaries are now essentially the same as the City's sound ordinance requirements, with a limit of 70 decibels and cutoff times of 8 PM Sunday-Thursday and 10 PM Friday and Saturday for outdoor performances.

Currently, four restaurants in the Barton Springs Road area (Restaurant Row) have active OMV permits:

> Uncle Billy's, Shady Grove, Baby Acapulco, and Flour and Vine.

Only two other neighborhood restaurants have OMV permits: Opa and Taco Xpress, both on South Lamar.





## ANC Proposes Clean Affordable Energy

THE AUSTIN NEIGHBORHOODS Council (ANC) will be considering the following resolution at its meeting on Wednesday, May 20. ZNA is a member of ANC. Our ANC delegate, Elizabeth Yevich, will present the resolution to the ZNA membership for a vote at our meeting on Monday, May 18. The complete resolution is available at www.ANCweb.org, under "Resolutions."

Whereas, energy produced at the coal-fired Fayette power plant and natural gas-fired Decker power plant causes environmental degradation in the form of air and water pollution; and

Whereas, Austin Energy has proposed to build a new natural gas-fired power plant that would emit air pollutants locally, contribute to air and water pollution in other parts of Texas by using natural gas that is obtained partly through hydraulic fracturing (fracking), and contribute to climate change; and

Whereas, the Austin Generation Resource Planning Task Force recommended increasing the goal for energy efficiency and demand response<sup>1</sup>; and

Whereas, the Austin Generation Resource Planning Task Force recommended replacing the existing highly polluting Decker natural gasfired power plant with west Texas solar generation<sup>2</sup>; and

Whereas, large quantities of precious and scarce water or wastewater would be used to cool a

new natural gas-fired power plant3; and


Whereas, investing in clean energy produces more jobs per dollar invested compared to fossil fuels<sup>4</sup>; and

Whereas, the proposed natural gas-fired power plant would be built on the east side of Austin, adding emissions harmful to health and adding to the significant past and current environmental injustices;

Now, therefore, be it resolved that the Austin
Neighborhoods Council, in order to create and
restore trust for public transparency, requests
that the Austin City Council ensure that the
consultant selected to conduct the independent
Generation Gap Study for Austin Energy provide to the public all unadulterated drafts and
the final version of the report, which shall be
based on unbiased and accurate data and assumptions; and

Be it further resolved that the Austin Neighborhoods Council requests that the Austin City Council retire the Fayette Power Project coalfired power plant and the existing Decker

Creek gas-fired power plant as quickly as possible; and not approve construction of any new fossil fuel-burning power plants, in keeping with the Austin Energy affordability goals; and

Be it further resolved that the Austin Neighborhoods Council requests that the Austin City Council direct Austin Energy to invest in clean energy, including solar, wind, energy storage, energy efficiency, and demand response to meet Austin's energy needs, protect public health, and keep electric rates affordable.

## ZNA: Frequently Asked Questions

How many members does ZNA have? At least 280 paid members will be eligible to vote in May. To join, see the form below or visit the ZNA Web site zilkerneighborhood.org.

How much are the dues, and what are they spent on? Dues of \$7 per person entitle the member to vote at quarterly and special meetings from Nov. 1 through Oct. 31. The dues support meeting expenses, the Web site, and other operating expenses.

Are donations to ZNA tax deductible? No. ZNA does not handle tax-deductible donations. When we raise money for a neighborhood project, donors are usually asked to give directly to

#### In the Beginning, There Was a Flood

Richard Gravois on ZNA's twenty-fifth birthday, excerpted from ZNews July 2006

"It was a dark and scary night when ZNA was founded on May 30, 1981, in response to a proposal to build the Kinney Avenue Condos. Then the rains came in biblical quantities, and on the next day we had the Memorial Day Flood. The condos were built two years later, and are now the Ashton Green Condos, but we took the message of the flood as incentive to get involved in sensible planning. Since then we have worked with developers and city staff to influence designs and do what we could to keep Austin as the very livable city that it is.

"Some of the changes since 1981:

"Traffic light at Kinney and Barton Springs. (Cars used to line up as far back as Kerr.)

"Zilker Place, Talisman, Zilker Skyline, Lamar widening, Barton Springs Road redesign, Umlauf Sculpture Gardens, footbridge over Barton Creek."

a public entity or foundation. For instance, donations for Little Zilker Neighborhood Park should be made to the LZNP account with the Austin Parks Foundation, not to ZNA.

Who does ZNA represent? Directly: The members. Indirectly: A larger cross-section through neighbor-to-neighbor discussions and the quarterly circulation of more than 2800 newsletters.

Who represents ZNA at various boards and commissions and at City Council hearings? The executive committee members who volunteer to go.

How does the ZNA Executive Committee arrive at a position on an issue? The committee considers several factors in determining a position that is consistent with the sentiment of the neighborhood,

beginning with the bylaws and previous decisions of the association and including, depending on the issue, the ZNA neighborhood planning survey conducted in 2004, the City of Austin neighborhood planning survey in 2005, the voting history of our neighborhood precincts, discussions and resolutions adopted at our quarterly meetings, direct discussions with affected neighbors, and consultation with city staff, board and commission members, and City Council members.

I want to build something that does not comply with city code. Will ZNA support my request for a variance? ZNA encourages all neighbors to comply with city ordinances. ZNA does not support variances unless the property has a unique physical feature that qualifies as a hardship under city code. Under state law, personal or financial circumstances do not qualify.

Does ZNA have design rules that limit house colors, landscaping, or other aesthetic standards? No. Within ZNA's boundaries, however, there are well over a hundred subdivisions and condominium or property-owner associations, each of which may have its own restrictive covenants and other rules. ZNA encourages all neighbors to understand and abide by the private covenants that apply to their properties.

Is zilker@yahoogroups.com the official list serve for ZNA? No. The Yahoo group, with more than 1000 members, is a useful communication vehicle, but it is not the official list serve for the association. It is owned and managed by Richard Gravois, who has kept it open to all residents, whether they are members of ZNA or not, since 1999. For more info, visit Yahoo.com and search "Groups" for "Zilker."



ZNA includes Zilker Park and Rabb Road on the west and extends to the railroad on the east, Barton Skyway on the south, and Lady Bird Lake on the north. Residents on both sides of boundary streets may join ZNA. ZNA is within City Council District 5.

(Continued from page 1) encouraged to host their own meetings, attend facilitated meetings, or participate in the online version. I cannot emphasize enough how important your feedback will be in informing my budget policy.

My office recently hosted a Budget in a Box opportunity during the April 28 Kitchen Cabinet meeting of District 5 neighborhood leaders. ZNA's cabinet leader is David King. He joined the group in these preliminary budget discussions in anticipation of sharing that experience with you all and spurring more participation from our District.

In late May or early June I will be hosting another District Town Hall meeting at which staff from the Budget Office will present a summary of what they heard from District 5 and provide another opportunity for input from our District. We are looking forward to and counting on an enthusiastic response from District 5!

Your feedback and participation is important as the new Council enters into the beginnings of its first budget conversation. The City's Budget Office will be taking initial public comment on budget issues until June 5. The inclusion of this portion of your feedback occurs at the beginning of the budget process, enabling it to contribute to staff's work as they create the Draft Budget.

There will be seven public hearings in the month of August to allow additional discussion on tax and utility rates and the overall budget.

## Budget in a Box, May 16, at Twin Oaks Library

Council Member Kitchen notes on page 1 of this newsletter that the City of Austin has started the budget process for the City's 2016 budget. As ZNA's president, I join her in urging you to participate in this historic opportunity for Austin's citizens to improve their local government through the 10-One City Council.

The City's budget office has a tool called Budget in a Box to facilitate citizen input on budget priorities. A neighborhood workshop on the Budget in a Box will be held from 2 to 4 PM on Saturday, May 16, at the Twin Oaks Library, 1800 South Fifth Street. Please look for more information about the workshop on ZNA's Web site or zilker@yahoogroups.com.


